

Orange County
Regulated Recyclable Material Collection License Application

Please read and understand the following terms and conditions:

- All vehicles with a Gross Vehicle Weight greater than 9000 lbs. subject to hauling waste loads of clean wood waste, metal, or cardboard (other than single-family unit collection vehicles with residential waste) in Orange County are required to be registered under a Recyclable Material Collection License.
Note: Front-loading vehicles servicing commercial establishments, including multi-family residential developments are subject to licensing and must be listed on your application.
- Businesses or Individuals are issued a Collectors' License; any number of vehicles may be registered under that license.
- License application fees are \$25 per vehicle if submitted before April 1, 2005 and \$15 per vehicle if submitted after April 1, 2006. Licenses are valid through October 1, 2005.
- Licenses are not transferable to other vehicles or other individuals or businesses.
- License applications must be delivered in person to Orange County Solid Waste Management at 1099 Airport Road or mailed to PO Box 17177 in Chapel Hill, NC 27516.
- Liability insurance must be maintained on all vehicles registered under the license
- Vehicles and containers used in the collection business must be durable, easily cleaned, and securely covered with a tarp or other adequate alternative covering when transporting waste.
- Licensed vehicles must display the County – issued license sticker prominently on the windshield near the NC DMV Inspection Sticker.
- Regulated Recyclable Materials (Clean wood waste, scrap metal, pallets, and corrugated cardboard) must be kept separate and recycled unless they are delivered to a Certified Commingled Recycling Facility.
- If Solid Waste Enforcement Staff observe waste mixed with Regulated Recyclable Material in a container or vehicle, either a "Verification Tag" OR a "Hold Tag" will be left visibly on the container hook, latch or other conspicuous place or on the vehicle windshield. Either: (1) The Verification Tag must be submitted to a Certified Recycling Facility. They will return it to the Solid Waste Department to confirm compliance. OR (2) The Hold Tag must remain on the container and no waste may exit the site. You must contact Solid Waste Enforcement Staff to arrange inspection to see that materials have been properly separated.
- **Bulk waste or roll-off type containers must be conspicuously marked with company or owner identification and must have distinct serial numbering prominently displayed on them.**
- Bulk waste or roll-off type containers must be accompanied by signage indicating what materials are intended or prohibited from collection in that container. For example, containers intended for collection of commingled waste and recyclable material must be noted as such while containers intended for separated un-recyclable waste must note that regulated recyclable material is prohibited
- **Haulers must declare county of origin of load at disposal facilities according to GS 130A-309.09D(b).**
- Improperly separated or disposed Regulated Recyclable Material arriving at Orange County Landfill is subject to a surcharge of double the current landfill tip fee.
- Illegally hauling or disposing of Regulated Recyclable Material subjects the hauler to Civil or Criminal penalties. \$50 for the first violation, \$100 for the second, and it increases by \$100 for each violation after that up to a maximum of \$500.
- Illegally hauling or disposing of Regulated Recyclable Material five (5) times in any 12-month period, or two (2) times in any 30-day period, will result in revocation of the collectors' license for one year from the time of revocation.
